Summary of the Characteristics of Pharmacists Enumerated

經點算藥劑師的特徵摘要

Executive Summary

I. Pharmacists Covered

- 1.1 The pharmacists covered in the 2007 HMS were pharmacists registered with the Pharmacy and Poisons Board of Hong Kong under the Pharmacy and Poisons Ordinance (Chapter 138) as at the survey reference date 31.8.2007.
- 1.2 The number of pharmacists covered was 1 705.
- 1.3 Of the 1 705 registered pharmacists covered, 1 061 had responded to the survey, giving an overall response rate of 62.2%. Among the respondents, 846 were economically active*† (active) in the local pharmacy profession as at 31.8.2007 and 215 reported to be economically inactive*† (inactive) in the local pharmacy profession (**Chart A**).

簡要報告

I. 所涵蓋的藥劑師

- 1.1 2007 年的醫療衞生服務人力統計調查所涵蓋的藥劑師,是指截至調查點算當日 (即 2007 年 8 月 31 日)已按《藥劑業及毒藥 條例》(第 138 章)的規定,向香港藥劑業 及毒藥管理局註冊的藥劑師。
- 1.2 所涵蓋藥劑師的人數爲 1 705 名。
- 1.3 在統計調查所涵蓋的 1 705 名註冊藥劑師中, 1 061 名作出回應,整體回應率為62.2%。在回應者中,有846 名藥劑師於2007 年8月31日在本港藥劑專業從事經濟活動*[†](在職)及215 名據報並非在本港藥劑專業從事經濟活動*[‡](非在本港從事業內工作)(圖甲)。



- 1.4 Of the 846 active pharmacists, 12 were seeking jobs in the pharmacy profession, two reported as temporary sickness and one was waiting to take up new job in the local pharmacy profession during the 30 days before the The survey results presented in survey. paragraph 1.6 below were based on the 831 pharmacists who were practising in the local pharmacy profession as at 31.8.2007. certain questionnaires contained missing information, percentages presented below may not add up to 100%.
- 1.5 Of the 215 inactive pharmacists, 97 reported practising overseas, seven reported practising in the Mainland and 109 reported not seeking job in the pharmacy profession during the 30 days before the survey (**Chart A**). Among the 109 inactive pharmacists who reported not seeking job, the main reasons reported for not seeking jobs included: 64 (58.7%) were working in other professions, 16 (14.7%) were retired, 13 (11.9%) wanted to take rest / having no motive to work / no financial need and nine (8.3%) engaged in household duties.
- 1.4 在 846 名在職藥劑師中,12 名在統計 日前 30 天內正在本港找尋藥劑專業的工 作,兩名據報暫時有病在身及一名正等待上 任新的藥劑專業工作。下文第 1.6 段所載的 統計調查結果,是指截至 2007 年 8 月 31 日, 根據 831 名在本港從事藥劑專業的藥劑師 所提供的資料而製備的。由於部分問卷資料 不全,下文所載的百分比總和可能不等於 100%。
- 1.5 在 215 名非在本港從事業內工作的藥劑師當中,有 97 名據報在外地執業,七 名據報在內地執業及 109 名據報在統計日前 30 天內亦無找尋業內工作(圖甲)。而在 109 名非在本港從事業內工作的藥劑師中,沒 有 尋 找 工 作 的 主 要 原 因 包 括:64 名(58.7%)正從事其他行業、16 名(14.7%)已退休、13 名(11.9%)希望休息/不想工作/財政上沒有需要及九名(8.3%)料理家務。

- 1.6 Among the 831 active pharmacists enumerated who were practising in the local pharmacy profession, 399 (48.0%) were male and 432 (52.0%) were female, giving an overall sex ratio (males per 100 females) of 92. Apart from the three pharmacists who did not indicate their age, the median age of the remaining 828 active pharmacists enumerated was 38.0 years. The median age of the active female pharmacists enumerated was 35.0 years and that of their male counterparts was 41.0 years.
- 1.7 The responding active pharmacists were requested to indicate the characteristics of their main jobs*. Distribution by sector showed that a large proportion (66.3%) of active pharmacists enumerated was working in the private sector, followed by those working in the Hospital Authority (27.9%), the Government (4.2%) and the academic and subvented sectors (1.6%).
- 1.8 The median age of the pharmacists enumerated was 39.0 years for those working in the government, followed by 38.0 years for those working in the private sector, 37.0 years in the academic and subvented sectors and 36.0 years in the Hospital Authority.

- 1.6 經點算的 831 名在本港從事藥劑專業職藥劑師中,399 名(48.0%)為男性,432 名(52.0%)為女性,整體性別比率(每百名女性的男性人數)為 92。除了三名藥劑師沒有註明年齡外,餘下 828 名經點算在職藥劑師的整體年齡中位數為 38.0 歲。經點算女藥劑師的年齡中位數為 35.0 歲,而男藥劑師的年齡中位數則為 41.0 歲。
- 1.7 我們要求作出回應的經點算在職藥劑師填寫其主要職位*的特徵。按主要職位所屬機構類型劃分的分布資料顯示,大部分(66.3%)經點算在職藥劑師在私營機構工作,其餘依次爲醫院管理局(27.9%)、政府(4.2%)和學術及資助機構(1.6%)。
- 1.8 經點算的任職政府藥劑師的年齡中位數為 39.0 歲,其餘依次為在私營機構(38.0 歲)、學術及資助機構(37.0 歲)及醫院管理局(36.0 歲)。

^{*} Main jobs referred to the jobs in which the pharmacist had spent most of their working time. 主要職位是指佔藥劑師大部分工作時間的職位。

- 1.9 Of the 831 active pharmacists enumerated, 71.7% spent most of their working time on service in pharmacy*, followed by 11.8% on administration / management† and 9.9% on manufacturing / marketing / sales‡.
- 1.10 The median number of hours of work (excluding meal breaks) per week of the 831 active pharmacists enumerated was 44.0 hours. 118 (14.2%) active pharmacists were required to undertake on-call duty, with a median of 12.0 hours of on-call duty (excluding normal duty) per week.
- 1.11 Of the 831 active pharmacists enumerated, 93.6% held Bachelor's degree, 3.5% held Master's degree and 1.2% held Doctoral degree as their basic qualifications.
- 1.12 Of the 831 active pharmacists enumerated, 462 (55.6%) received / were receiving additional training and 369 (44.4%) did not receive any additional training.

- 1.9 在 831 名經點算在職藥劑師中,71.7%把大部分工作時間用於藥劑服務*,其餘依次為行政/管理 † (11.8%)及製造/市場推廣/銷售 ‡ (9.9%)。
- 1.10 經點算的 831 名在職藥劑師中,每週工作時數中位數(不計用膳時間)為 44.0 小時。另 118 名(14.2%)在職藥劑師在現任職位中需作隨時候召的工作,而每週隨時候召工作(不計日常職務)時數的中位數為 12.0 小時。
- 1.11 在 831 名經點算在職藥劑師中, 93.6%持有學士學位,3.5%持有碩士學位及 1.2%持有博士學位作爲基本資格。
- 1.12 在 831 名經點算在職藥劑師中,462 名(55.6%)曾接受/正接受額外訓練,369 名(44.4%)沒有受過任何額外訓練。

- 1.13 Of the 462 active pharmacists with additional training, 47 (10.2%) had not yet completed the additional training, 230 (49.8%) held Master's degree, 62 (13.4%) held Certificate, 35 (7.6%) held Graduate Diploma and 34 (7.4%) held Diploma.
- 1.14 Of the 462 active pharmacists enumerated who received or were receiving additional training, 367 (79.4%) were trained in one field of additional training. Among them, 48.5% were trained in clinical pharmacy, 21.3% in Chinese medicine, 8.2% in pharmacy, 6.8% in health administration, 3.5% in pharmaceutical science and 3.5% in medical sciences.
- 1.15 Regarding Continuing Education Training activities, 715 (86.0%) of the active pharmacists revealed that thev in participated Continuing Education Training activities in 2007, 103 (12.4%) did not participate in any Continuing Education Training activities and 13 (1.6%) did not reveal whether they had participated in Continuing Education Training activities or not. Among the 715 active pharmacists enumerated who had participated Continuing Education Training activities, the distribution of Continuing Education Training hours attained in the past 12 months was: 1 to 10 hours (21.4%), 11 to 20 hours and 21 to 30 hours (both being 19.0%), 31 to 40 hours (7.8%) and more than 40 hours (18.8%).

- 1.13 在 462 名有接受額外訓練的在職藥劑師中,47 名(10.2%)還未完成額外訓練,230 名 (49.8%)持有碩士學位、62 名(13.4%)持有證書、35 名(7.6%)持有修業文憑及34 名(7.4%)持有文憑。
- 1.14 在 462 名曾接受/正接受額外訓練的經點算在職藥劑師中,367 名(79.4%)接受一項額外訓練;當中 48.5%人士正接受臨床藥劑學訓練,中醫藥學佔 21.3%、藥劑學佔 8.2%、衛生管理學佔 6.8%、藥劑科學佔 3.5%及醫學科學佔 3.5%。
- 1.15 關於持續進修活動,715 名(86.0%) 在職藥劑師表示在 2007 年曾參與有關持續進修活動,103 名(12.4%)並沒有參與任何持續進修活動及 13 名(1.6%)沒有註明曾否參與有關持續進修活動。至於715 名曾參與有關活動的經點算在職藥劑師中,表示在過去12 個月所獲得的時數為: 1 至10 小時(21.4%),11 至 20 小時及 21 小時至30 小時(兩者均爲 19.0%),31 至40 小時(7.8%)及多於40 小時(18.8%)。

II. Trend Analysis

- 2.1 Comparison of findings of the 2007 HMS with those surveys before 2004 should be cautious as the survey methodology and reference date had been changed.
- 2.2 A total of 1 705 pharmacists were covered in 2007 HMS, representing an increase of 32.3% over the 2000 HMS (1 289). Compared with the 1982 HMS, the number of pharmacists covered in the HMS recorded an average annual growth rate of 5.9% (**Chart B**).

II. 趨勢分析


- 2.1 醫療衞生服務人力統計調查的統計 調查方法及點算日均已改變,故將 2007 年 與 2004 年以前的統計調查結果比較時必須 小心謹慎。
- 2.2 2007年統計調查共涵蓋1705名藥劑師,對比2000年統計調查所涵蓋的1289名增加32.3%。與1982年統計調查比較,該數字錄得5.9%的每年平均增長率(圖乙)。

- 2.3 There was a decreasing proportion of male pharmacists. The overall sex ratio (males per 100 females) had shown a continuous decrease from 199 in 1984 to 92 in 2007 (**Table A**).
- 2.4 The mean age of the active pharmacists enumerated increased gradually from 36.1 years in 1982 to 39.2 years in 2007 (**Table A**).
- 2.5 From 1982 to 2007, the private sector accounted for the largest proportion of active pharmacists enumerated, ranging from 63.0% to 73.1%. Prior to the establishment of the Hospital Authority in 1991, more than one-fifth of active pharmacists enumerated worked in the Government (20.7% to 25.9%); and the proportion decreased to less than 7% from 1992 onwards. The proportion in the Hospital Authority increased from 18.9% in 1992 to 27.9% in 2007 (**Table A**).

- 2.3 男性藥劑師的比例顯示下降的趨勢,整體性別比率(每百名女性的男性人數)由 1984年的 199,持續下跌至 2007年的 92 (表甲)。
- 2.4 經點算在職藥劑師的平均年齡,由 1982年的 36.1 歲,漸漸上升至 2007年的 39.2歲(表甲)。
- 2.5 在 1982 年至 2007 年期間,經點算在職藥劑師以任職私營機構的人數最多,佔63.0%至 73.1%。在醫院管理局於 1991 年成立之前,多於五分之一的在職經點算藥劑師任職於政府(20.7%至 25.9%),該比例在 1992 年以後減至少於 7%。任職醫院管理局的在職藥劑師比例則由 1992 年的 18.9%,上升至 2007 年的 27.9%(表甲)。
