2005 Health Manpower Survey on Optometrists 2005 年有關視光師的醫療衞生服務人力統計調查 **Key Findings**

結果摘要

- The optometrists covered in the 2005 HMS were optometrists registered with the Optometrists Board of Hong Kong under the Supplementary Medical Professions Ordinance (Chapter 359) as at the survey reference date, i.e. 31.3.2005.
- The number of optometrists covered in the 2005 HMS was 1898.
- Of the 1 898 registered optometrists covered, 1 353 had responded to the Survey, giving an overall response rate of 71.3%. As at 31.3.2005, 1 304 of the responding optometrists were economically active*[†] while 48 reported to be economically inactive*[‡] in the local optometry profession (See Chart) (thereafter referred to as "active" and "inactive" respectively).
- Of the 1 304 active optometrists, 1 294 were practising in the local optometry profession, five were seeking jobs and five reported having temporary sickness during the 30 days before the Survey.
- The survey findings presented below were based on the 1 294 responding optometrists practising in the local optometry profession as at 31.3.2005. As certain questionnaires contained missing information, percentages presented below may not add up to 100%.
 - Four optometrists who did not indicate their Among the remaining 1 290 active optometrists enumerated, 1 059 (82.1%) were male and 231 (17.9%) were female, giving an overall sex ratio of 458 (males per 100 females). Nine optometrists did not indicate their age; and the median age of 1 285 active optometrists enumerated was 41.0 years old.
 - Regarding the main job[§], the distribution by sector showed that a large proportion of the active optometrists enumerated was working in the private sector (93.4%), followed by the Government, academic and subvented sectors (4.1%), and the Hospital Authority (1.9%).
 - (iii) Analysed by highest percentage of time spent on the area of work of the main job, 89.1% of the 1 294 active optometrists spent most of their working time on service of optometric care, followed by administration / management (4.2%) and research (0.9%).

- 2005 年的醫療衞牛服務人力統計調查,涵蓋截至 調查點算當日(即 2005 年 3 月 31 日)已根據《輔助 醫療業條例》(第359章)的規定向香港視光師管理 委員會註冊的視光師。
- 2005 年的醫療衞生服務人力統計調查所涵蓋視光 師的人數爲 1898名。
- 在統計調查所涵蓋的 1898 名註冊視光師中,有 1353 名作出回應,整體回應率為71.3%。在回應 者中,有1304名視光師於2005年3月31日在本 港視光專業從事經濟活動 * 7, 有48 名據報並非在 本港視光專業從事經濟活動*1(見圖)(下文分別以 "在職"(意指從事業內工作)及"非在本港從事業內 工作"代替)。
- 在 1 304 名在職視光師中, 1 294 名在本港從事視 光專業工作,5 名在統計日前30 天內正在找尋找 尋視光專業工作,另有 5 名視光師塡報暫時有病 在身。
- 下文所載的統計調查結果,是根據 1294 名於 2005年3月31日在本港從事視光專業的視光師所 提供的資料而製備的。由於部分問卷資料不全, 下文所載的百分比總和可能不等於 100%。
 - 剔除4名沒有註明性別的視光師後,在餘下經 點算的1290名在職視光師當中,男性佔 1059名(82.1%),女性佔231名(17.9%),整 體性別比率爲458 (每百名女性的男性人 數)。9名視光師沒有註明年齡,而餘下 1285 名經點算在職視光師的整體年齡中位 數爲41.0歳。
 - (ii) 按主要職位[§]所屬機構類型劃分的分布資料 顯示,大部分經點算在職視光師在私營機構 工作(93.4%),其次爲政府、學術機構及資助 機構(4.1%)及醫院管理局(1.9%)。
 - (iii) 對主要職位工作範疇的最高工作時間百分 比所作的分析顯示,在1294名在職視光師 中,把大部分工作時間用於視光護理的佔 89.1%,其餘依次爲行政/管理(4.2%)及研究 (0.9%) °
- In the Survey, the criteria used in defining economically active and inactive followed those recommended by the International Labour Organization, which are also being used by the Census and Statistics Department in Hong Kong.



- "Economically active" optometrists comprised all "employed" and "unemployed" optometrists. The "employed" optometrists referred to those optometrists practising in the optometry profession in Hong Kong during the Survey period, while the "unemployed" optometrists referred to those optometrists who (a) were not practising in the optometry profession during the Survey period; (b) had sought work in the optometry profession during the 30 days before the Survey; and (c) had been available for work during the seven days before the Survey. "從事經濟活動"的視光師包括所有"就業"及"待業"視光師。"就業"視光師是指統計調查期間在本港從事視光專業的視光師,而"待業"視光師則
 - 指(a)在統計調查期間並非在本港從事視光專業: (b)在統計日前30天內正在找尋視光專業工作;及(c)在統計日前7天內能夠上班的視光師。
- ‡ "Economically inactive" optometrists comprised the optometrists who were not practising in the optometry profession in Hong Kong during the Survey period, but excluding those who had been on leave during the Survey period and who were "unemployed".
 - "非從事經濟活動"的視光師包括在統計調查期間並非在本港從事視光專業的視光師,但不包括在統計調查期間休假及"待業"的視光師。
- § Main jobs referred to the jobs in which the optometrists had spent most of their working time. 主要職位是指佔視光師大部分工作時間的職位。

- (iv) The median number of hours of work (excluding meal breaks) per week of the 1 294 active optometrists enumerated was 60.0 hours. 120 (9.3%) optometrists were required to undertake on-call duty in their posts. Their median number of hours of on-call duty (excluding normal duty) per week amounted to 12.0 hours.
- ➤ The distribution of the 48 inactive optometrists was as follows (See Chart):-
 - (i) 14 optometrists reported practising overseas and six reported practising in the Mainland.
 - (ii) 28 optometrists reported not practising in the optometry profession in Hong Kong and not seeking job in the optometry profession during the 30 days before the Survey. Among them, the reasons reported for not seeking job included: working in other professions (53.6%), retired (25.0%) (with median age being 66.0 years old).

- (iv) 經點算的1 294名在職視光師每週工作時數中位數(不計用膳時間)為60.0小時。120 名(9.3%)視光師在現任職位中須擔任隨時候召工作。他們的每週隨時候召工作時數中位數(不計日常職務時間)為12.0小時。
- ▶ 非在本港從事業內工作的48名視光師的分布如下 (見圖):
 - (i) 有14名視光師據報在外地執業;另有6名在內 地執業。
 - (ii) 有28名視光師據報並非在本港從事視光專業工作,而在統計日前30天內亦無找尋業內工作。這些視光師當中,沒有尋找業內工作的原因包括:從事其他行業(53.6%)及退休(25.0%)(年齡中位數爲66.0歲)。
